As part of the "Field Trip Program" offered by Cascade, FCS is planning an all school ski day. Sandee Hoksbergen is organizing the ski day this year, if you have any questions. Please turn all your paperwork into her or the school office by Monday, January 20.

ALL skiers will need the liability consent forms completed. The liability forms are found on the Cascade website and attached to this. I would request that any student must also have an adult chaperone responsible for them. The adult chaperone does not need to be the student's parent and an adult chaperone may be responsible for more than one student. This is necessary because sometimes the younger students tire quicker, become cold/wet and want to go home. Also due to the nature of skiing/snow boarding, it is difficult to know where all the students are at any given time and is very important that the students "buddy up" as it is easy to get separated and "lose" one another.

Cascade offers a pre-paid meal voucher plan or students can pack a lunch and any other snacks, drinks, etc. The meal voucher includes a sandwich, chips, and pop. (The duluxe voucher offers a few more sandwich options.) Tables and lockers are available in the snack bar/cafeteria area. Information is on the attached forms, please fill the forms out and return by January 20.

Group ski or snow board lessons for students **10 years old and up** are still offered but are **not** included in the Field Trip Program. The lessons will cost an additional \$10/person. Again, please see the attached forms.

The Field Trip Program is from 9:00am – Close. We will meet at Cascade at 9:00am. Others may join our group at Cascade later in the day; however, I will not be there all day so I would ask that you arrange that someone be there to take your lift ticket in the morning and hold on to it until you get there.
